Complaints about a property and bids for a new furnace were among some of things discussed at the Monday, July 3 meeting of the Herrick Township Supervi-

In old business, another complaint was made about the Ryan Brown property on Stark Road. Supervisor/Secretary Nancy Harvatine said Zoning Officer John Watts got a call about it. She said the township's solicitor told her it is up to the supervisors to have Watts go and check the property. Supervisor Elliot Ross made a motion authorizing Watts to go and inspect it one more time. Ross, Harvatine and Supervisor Brian Zembrzycki all voted in favor. Motion passed.

Ross raised concerns about doing paperwork for Act 172 - Local Tax Credits for Volunteer Firefighters and EMS. "We aren't going to be saddled with a bunch of paperwork to save someone \$20?,"

Harvatine said they could give a 20% discount for vol-

Ross agreed but asked how much paperwork is involved. Harvatine said, Township News said the township is responsible for the paperwork but I want to read the whole article."

The supervisors agreed to table it until they got more information on it.

Harvatine said she and EMA Coordinator Andy Belcher attended a meeting in Montrose last month with Bob Thatcher Jr., Director of the Susquehanna County Emergency Management and other municipalities. He told them municipalities are on their own the first 72 hours after an emergency. Twentyfive percent of the county's EMA budget will be cut by the federal government.

He also talked about Smart911 and Code Red, a notification system in which local emergency officials will notify people of emergency situations or critical community alerts like evacuation notices and missing child reports. To sign up to receive alerts, visit, www.codered.

Laurel Muller, President of Soil Services Company sent the township a copy of the letter that was sent to Camp informing Chen-a-wanda, them of the approval of the Sewage Treatment Plant and Spray Field.

The township received \$80,116.28 in Act 13 funds. Harvatine asked if they should put the money in the money market account at PS Bank. Ross and Zembrzycki agreed.

Havatine said COG is taking care of an inquiry about a pull-behind camper at Lowe Lake. She said she received a call about a noise complaint. The man asked if there was an ordinance about noise. He said his neighbor was playing music at night. She told him about Ordinance #9 in which the person could call the state

Zembrzycki said the roads have all been graded, sprayed with calcium and have been cut and they are now working on ditching.
